

SCHEDULE 1 - THE WORK

Explorer Mastermind

- 1.1. The Provider shall offer and facilitate Bi-Monthly meetings of no less than a 7.5Hr duration for a specific group of Clients who have agreed to join together and support each other's personal development and business growth.
- 1.2. Each meeting shall take place at a pre-determined venue suitable for such activities, and shall take part over a 24Hour period.
- 1.3. Clients shall be invited to join the Provider by 19.00Hrs the evening prior to each meeting, to attend private dining over which they shall be asked to share with the group, an update as to them and their business, and what actions they have taken to improve themselves and their business.
- 1.4. Over the course of the following day, each client shall take to the 'HOTSEAT' and share with all other members present, their aspirations and goals (Personal and Professional) and their current hurdles (Personal and Professional) which need to be overcome in order to achieve their Aspirations / Goals.
- 1.5. Each member shall contribute their knowledge, experience, expertise to aide each other in overcoming these hurdles quickly and effectively to accelerate the time and efficiency of achieving the aspirations / goals.
- 1.6. A digital recording of the event shall be made, and shared with those present to prevent the need for note taking and enable the client to refer back to all information shared.

- 1.8. Between each meeting, The Provider shall make time available to work with each client 1:1.
